

A Special Meeting of the Ellington Board of Education was held on Friday, May 26, 2023, in the Board of Education Conference Room, 47 Main Street, Ellington, Connecticut.

The meeting was called to order at 12:00 p.m. by Angie Moser.

Move that this committee of the Ellington Board of Education enter Executive Session to discuss a matter that would result in the disclosure of public records or the information contained therein as described in Connecticut General Statutes Sections 1-210(b)(2) (11) and (17). Further, that the committee invite the following individuals to attend the Executive Session: Student, Student's Parent, Superintendent Scott V. Nicol, Board's Counsel Frederick L. Dorsey.

Move that pursuant to Connecticut General Statutes Section 10-233d, the Ellington Board of Education shall expel the Student discussed in Executive Session from attendance at Ellington High School for the period from May 18, 2023, through and including October 27, 2023, for the reasons presented by the Administration in this hearing and the Stipulated Agreement. Further, the Board directs the Administration to offer an alternative educational opportunity to the Student for the period of this expulsion, pursuant to Connecticut General Statutes Section 10-233d(d). The Superintendent is also authorized to allow early readmission on or after September 29, 2023, if the Student meets the conditions for early readmission provided in the Stipulated Agreement, which will be attached hereto and made a part hereof. Upon any early readmission, the Student will be on probation for the remainder of the expulsion period but will be allowed to participate in school activities. During this period of probation, the Student must meet all the probationary conditions specified in the Stipulated Agreement. If these conditions are not met during the

probationary period, the Superintendent is authorized to reinstate the remaining term of the Student's expulsion without the necessity of any further action by the Board. The Board further directs the Administration, pursuant to Connecticut General Statutes Section 10-233d(f), to record this expulsion on the Student's cumulative educational record, to be expunged from such record if the Student graduates from high school. Finally, the Board authorizes Angela Moser and Fred Dorsey to communicate in writing to the Student and/or his/her parents, as appropriate, the Board's decision and the reasons therefor, consistent with the Board's Executive Session discussion.
The motion passed unanimously.
