State Provides Relief for Windermere School Project to Address Crumbling Foundations Concern

Higher Reimbursement Rate to Save Ellington Taxpayers an Estimated \$9 Million

ELLINGTON, CT – The state legislature recently passed a measure in the school construction portion of the budget implementation bill that provides additional funding for the Windermere Building Project. The language increases the reimbursement rate from 55.36% to 70%, netting savings to Ellington of just over \$9 million on the \$61 million project.

The bill also makes the project eligible for State funding once the application is submitted to the State Office of School Construction Grants and Review. As the Town was previously expecting funding commitment in 2023, the project schedule will move forward six months earlier than previously anticipated.

The legislation cited the presence of pyrrhotite in the foundation as the reason for the increase in funding. Ellington school officials have previously stated that levels of the mineral pyrrhotite in a 2002 addition are consistent with those that have caused issues with crumbling foundations in the area, but have stressed there are no immediate safety concerns.

The project recently passed at Town referendum in March with an estimated cost to the taxpayers of \$29 million. That projection used the 55.36% reimbursement rate set by State statute.

"These measures have a direct impact on the Ellington taxpayers, saving them significant amounts of principal and interest in the long-term, but they also provide more flexibility to deal with unique challenges in the current construction market," stated **Brian Greenleaf**, **Director of Finance and Operations for the Ellington Public Schools**.

Advancing the project by six months allows the Town to theoretically avoid escalation costs—the inflation of construction materials and labor over time. In the years prior to 2020, escalation in non-residential construction ranged around 4.5% per year. In 2021, non-residential construction increased closer to 8%.

Greenleaf notes, "Advancing the schedule means our project dollars go further. This gives us more options as we look to go from project concept to ribbon cutting."

The district administration partnered with the delegation, led by the efforts of State Representative Jaime Foster, to push for Windermere to be included within this year's school construction bill.

The bill has been transmitted to the Governor's Office where it is awaiting signature.
